Unless the context otherwise requires, all the expressions used in this Authority shall have the same meanings as in the Securities and Futures Ordinance and the Securities and Futures (Client Money) Rules as amended from time to time. - III. to enter into foreign exchange contracts necessary to facilitate the purchase or meeting the settlement or margin requirement (if applicable) of the overseas futures contracts on or before the day when funds are required to be converted into other currencies for payment at market rates and in accordance with ZYSL normal practice.
